3. The firm should have regn. No. EPF, ESI No. and registration of Excise & Taxation Deptt, GST Pan No.
4. The service provider shall maintain the EPF & ESI record of the entire workmen separately, as per the provisions of Employees Provident fund and Misc. Provision Act 1952 and Employees State Insurance 1948.
5. The service provider shall submit the full details of each employee with ESI, EPF No Bank A/c No, detail of deductions and full address.
6. The service provider shall have the license of ADGP Haryana as prescribed under Haryana private security Agencies rules, 2009 and shall have minimum two allotment orders of Govt offices.
7. The committee reserves the right to accept or reject any tender without assigning any reason.
8. The successful bidder will submit his original documents at the same time.
9. Conditional Tender will not be entertained & are liable to be rejected.
10. The jurisdiction of court will be at Rohtak.
